

# David W. Leebron Human Rights Fellowship 2026

Columbia Law School announces the 2024 David W. Leebron Human Rights Fellowship, which honors the Law School's former dean (1996-2004) and his commitment to providing meaningful experiences in human rights law. This fellowship will enable a Columbia Law School graduate to spend one year working in human rights in the U.S. or abroad. **Applications are due on February 22, 2026.** 

# **Terms of the Fellowship**

The Leebron Fellowship will be awarded for a one-year term. The fellowship is available to graduates of Columbia Law School who are (1) members of the Class of 2026 pursuing a J.D. or LL.M. degree, including those who will graduate in October 2025 or February or May 2026, or (2) current state or federal judicial clerks whose clerkships will terminate by fall 2026.

The fellowship is designed to enable a Columbia Law School graduate interested in pursuing a career in human rights law to gain practical experience working with a human rights organization. Through this year of practical training, the fellowship aims to provide the graduate with the skills necessary to start or advance a career in the field of human rights law, whether in academic life, in governmental, intergovernmental, or nongovernmental organizations or agencies, or as legal practitioners specializing in human rights work. The fellowship carries a stipend of \$50,000 a year and must begin within five months of graduation or of completion of a clerkship.

Applicants must not have a full-time job or a fellowship, stipend, or other source of funding to work during the time for which the fellowship is sought.

#### **Qualifying Placements**

Host organizations must be engaged in human rights law advocacy. In most cases, these organizations or agencies will be involved in human rights education, monitoring, reporting, litigation, grassroots mobilization, or other forms of advocacy. They may be involved in human rights work in general or in specific areas of the human rights movement such as, but not limited to, women's rights, children's rights, labor rights, refugee rights, humanitarian law, transitional justice, health care, and so on. Most qualifying organizations would identify themselves as part of the broader universal human rights movement, relying on the norms declared in international and regional treaties and declarations.

Qualifying hosts may include organizations embracing new and interdisciplinary directions in the human rights movement, such as those following in substantial part a rights-based approach to economic development, humanitarian relief, media, health, or environmental activism. In special circumstances,

the fellowship selection committee may accept a proposal for work within a governmental or intergovernmental human rights organization.

Qualifying placements may also include nonprofit organizations in the U.S. at which the majority of the fellow's work will use the international human rights law paradigm to combat domestic social justice issues. Please note: The fellowship selection committee understands that projects and/or host organizations proposed in this application may be tenuous or uncertain prior to an award of funding. The committee will allow changes to the fellow's project or host organization as long as they are within the parameters of the fellowship as outlined in this notice of application.

Fellows must be supervised by a lawyer at the host organization.

# **Application and Selection Procedure**

To apply, please follow the instructions on the next page. Applications are reviewed by a committee of Columbia Law School faculty, administrators, and human rights practitioners. Fellows will be selected by the end of March 2026.

# **Stipend and Payment Process**

Unless their host organizations ask to have the stipend transferred to the organization, fellows are paid by Columbia Law School in monthly installments. Funds are not available before fellows commence work. Stipends are subject to U.S. taxes.

#### **IMPORTANT NOTE**

If either of the following circumstances apply to you, please follow the instructions below PRIOR TO APPLYING:

- You plan to start your fellowship prior to July 1, 2026:Please reach out to Rebecca Hinde at rh2523@columbia.edu to discuss the payment schedule.
- Your proposed host organization is an intergovernmental agency such as the United Nations or
  World Bank, you plan to serve your fellowship within the United States, and you will require a visa
  to work in the United States: Please reach out to Rebecca Hinde at rh2523@columbia.edu
  immediately as there are restrictions on paying fellowship stipends to holders of certain visa types.
  If you do not receive proper guidance, you may not be eligible to receive a fellowship, so it is very
  important that you speak to Rebecca Hinde ASAP and definitely BEFORE you submit your
  application.

### **Fellowship Contacts**

### **Application Instructions**

Please visit <u>cglink.me/2it/s78692</u> to upload the following documents. Applications are due by 11:59 p.m. on February 22, 2026.

- 1. Your resume
- A personal statement (1,000 words maximum) about your relevant experience, interest, and future
  aspirations with respect to public interest and human rights legal work. The statement should
  include a discussion of the fellowship's place in your career plans. PLEASE INCLUDE YOUR NAME ON
  THE DOCUMENT.
- 3. A project description (3 pages maximum) that includes the following. PLEASE INCLUDE YOURNAME ON THE DOCUMENT.
  - a. A description of the host and its work in the local and international context.
  - b. A description of your project and its relation to the work of the proposed host organization.
  - c. An estimated budget (to demonstrate feasibility).
- 4. Your UNOFFICIAL Columbia Law School transcript.
- 5. A commitment letter from a host organization that demonstrates that it is a qualified employer for purposes of this fellowship and describes the work, training, and supervision that you will receive if the application is successful. If you are a J.D. student, the letter MUST also state<sup>1</sup>:
  - a. The term of the fellowship as a full-time one-year position.
  - b. That Columbia Law School will provide funding of \$50,000 per year.
  - c. If the host will supplement the stipend with its own funds, the amount the host will pay you.
- 6. One letter of recommendation, preferably from a Columbia Law School faculty member or a supervisor at a relevant organization. If the recommender would prefer, they can email the letter to rh2523@columbia.edu by the application deadline.
- 7. Identification of two ADDITIONAL people who could serve as references and their contact information, including their email addresses and phone numbers.

<sup>&</sup>lt;sup>1</sup> The American Bar Association requires Columbia Law School to report on any fellowships the Law School awards to its graduating J.D. class. For each fellow, the report must include a host letter that acknowledges the fellowship duration and stipend amount and specifies that the stipend is being provided by Columbia Law School. If the host is supplementing the stipend with its own funds, the letter must state this, with the supplement amount included in the letter. We ask that applicants ensure that their letter includes this information. Thank you.
