## 2023 Distinguished Graduate Honoree and Keynote Speaker



Anurima Bhargava '02 is the founder and director of Anthem of Us, a strategic advisory and consulting firm that centers dignity, justice, and belonging in workplaces, schools, and communities. Clients include leading financial institutions, corporations, foundations, schools, and media, arts, and nonprofit organizations.

From 2018 to 2022, she served as chair and commissioner of the U.S. Commission on International Religious Freedom, which documents and makes recommendations on religious persecution and violence abroad. She made diplomatic visits to Burma, the Rohingya camps in Bangladesh, Iraq, Sudan, and Vietnam. Her engagement on the commission was recently profiled in the New York Times.

From 2010 to 2016, Bhargava led federal civil rights enforcement and policy in schools and higher education institutions across the nation at the U.S. Department of Justice, where she spearheaded landmark guidance and litigation on school discipline, sexual harassment and violence, English Learners, and students with disabilities. She served on several administration-wide and White House task forces to address harassment, discrimination, and violence.

She previously served as director of the education practice and associate counsel at the NAACP Legal Defense Fund from 2004 to 2010, where she litigated cases on diversity and segregation in schools and higher education institutions, including in the federal appellate courts and U.S. Supreme Court.

From 2016 to 2018, she was a fellow at the Institute of Politics and the Carr Center for Human Rights at Harvard and a Leadership in Government Fellow at Open Society Foundations, where she focused on trauma experienced after incidents of communal racial violence.

Bhargava's commitment to advancing dignity and justice through narrative and storytelling led her to produce and advise numerous documentary films and projects. She chairs the U.S. board of Doc Society, a leading incubator and supporter of documentary film globally. Her recent projects include the Oscar-nominated documentary *Writing with Fire* (co-executive producer), *Barefoot Empress* (executive producer); and the docuseries *The Vow* (consulting producer/legal advisor).


She co-chairs the National Advisory Board on Public Service at Harvard and serves on the board of the National Women's Law Center Action Fund and Big Thought. She also serves as an advisor to GSV Ventures, Unbound Philanthropy, and the Broadway Advocacy Coalition. She was a 2017 Presidential

Leadership Scholar.

Bhargava advises numerous political campaigns and was appointed to the 2020 Democratic National Committee's Platform Committee. She founded Take Back Tuesdays and Anthem of America to provide information and ways to take action around elections, and a multiracial PAC, American Anthem.

Bhargava earned her law degree from Columbia Law School and graduated magna cum laude from Harvard College. She was recently elected chief marshal of her Harvard class. She was born and raised on the south side of Chicago.

## **Joint Introduction to Keynote Speaker**



**Kendall Thomas**, Nash Professor of Law, is a scholar of comparative constitutional law and human rights whose teaching and research focus on critical race theory, legal philosophy, feminist legal theory, and law and sexuality.

Thomas is the co-founder and director of the Center for the Study of Law and Culture at Columbia Law School, where he leads interdisciplinary projects and programs that explore how the law operates as one of the central ways to create meaning in society. He is a founder of Amend the 13th, a movement to amend the U.S. Constitution to end enforced prison labor.

His seminal writing on the intersection of race and law appears in Critical Race Theory: The Key Writings That Founded the Movement (1996), which he co-edited. He is also

a co-editor of Legge Razza Diritti: La Critical Race Theory negli Stati Uniti (2005) and What's Left of Theory? (2000).

Thomas has taught at Columbia Law since 1986. He has been a visiting professor at Stanford Law School and a visiting professor in American studies and Afro-American studies at Princeton University. His writing has appeared in volumes of collected essays and in journals including National Black Law Journal, Widener Law Symposium Journal, and Columbia Journal of European Law.

Thomas was an inaugural recipient of the Berlin Prize Fellowship of the American Academy in Berlin and a member of the Special Committee of the American Center in Paris. He has chaired the Jurisprudence Section and the Law and Humanities Section of the Association of American Law Schools.

Thomas has written and spoken widely on the impact of AIDS and was a founding member of the Majority Action Caucus of ACT UP, Sex Panic!, and the AIDS Prevention Action League. A former board member of the Gay Men's Health Crisis, he now serves on the board of the NYC AIDS Memorial. Thomas is also a professional jazz vocalist who performs at venues including Joe's Pub and is on the board of advisors of the Broadway Advocacy Coalition.



**Susan P. Sturm** is the George M. Jaffin Professor of Law and Social Responsibility. Her work focuses on inequality, discrimination, remedying racial and gender bias, criminal justice reform, lawyer-leadership, and the role education can play in creating social change and a more inclusive world.

Sturm is a co-chair and architect of Columbia Law School's Davis Polk Leadership Initiative, a cross-disciplinary effort to prepare students to succeed as leaders in a wide range of sectors. Sturm teaches Civil Procedure, Lawyering for Change, and Lawyer Leadership: Leading Self, Leading Others, Leading Change. She is the founding director of the Center for Institutional and Social Change and a Provost Senior Faculty Teaching Scholar. She received Columbia University's Presidential Teaching Award in 2007.

Sturm has written and spoken extensively about race, gender, legal education, and full participation in higher

education and filed an amicus brief with the U.S. Supreme Court in support of the University of Texas in a case challenging its race-conscious admissions process. In 2017, she co-authored a report called Leading with Conviction, which examines how and why some people emerge from prison as community leaders. In 2015, she completed a study on diversity and inclusion among authors and editors of the *Yale Law Journal*, which provided insights relevant to the larger field of legal education. At the Center for Institutional and Social Change, which she founded in 2007, Sturm leads collaborative action research projects with institutional and community leaders in the areas of education, criminal justice, and community development. She collaborates with a wide variety of higher education, government, and community-based organizations including the Massachusetts Trial Courts, the Center for Justice, the Aspen Ascend Network, Hostos Community College, and JustLeadershipUSA. She is the co-creator of Theaters of Change, a joint effort with the Center for Institutional and Social Change and the Broadway Advocacy Coalition to bring together individuals directly impacted by mass incarceration, high-level theater artists, and advocates and policymakers focused on humanizing and transforming the criminal legal system.

Sturm is the principal investigator for a grant from the Commonwealth of Massachusetts and has developed a curriculum for building leadership capacity to address race and bias in the Massachusetts Trial Courts. She has served as the principal investigator on two Ford Foundation grants for projects designed to increase access to postsecondary education for immigrants, veterans, and communities affected by incarceration. She also received an Aspen Ascend grant to develop multigenerational strategies for advancing higher education for communities affected by the criminal justice system.
