

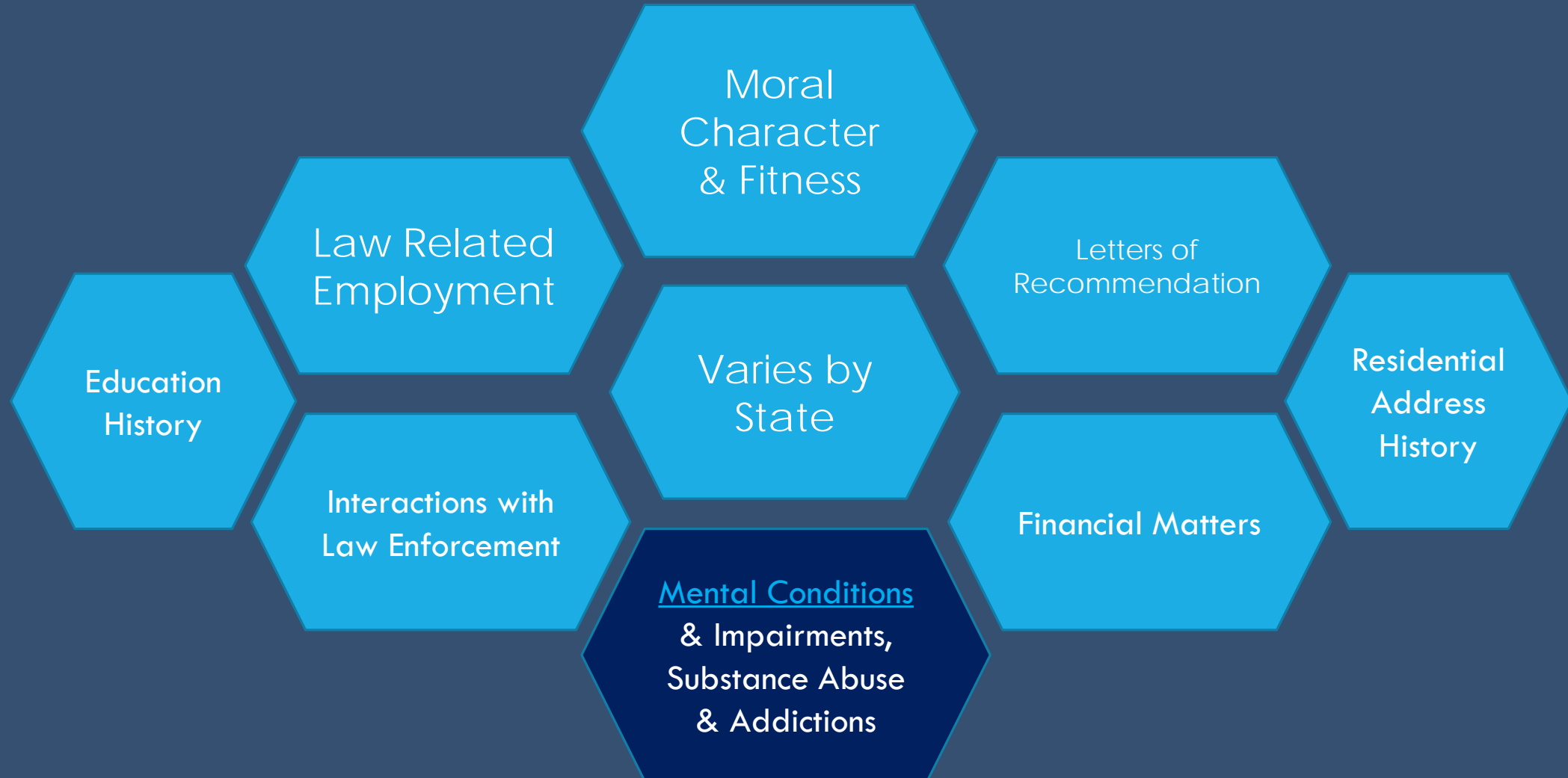

- Provide Affidavits for each pro bono project that satisfies the 50-hour requirement
- (2) original good moral character affirmations
- Skills Form Affidavit (LL.M. students: Pathway 4 or Pathway 5)

Submit these documents to Registration Services for certification:

- Form Law School Certificate (JD and LL.M. students)
- Skills Form Affidavit (JD students only: Pathway 1)

File the complete Application for Admission within three years from the date when you sat for the bar examination.

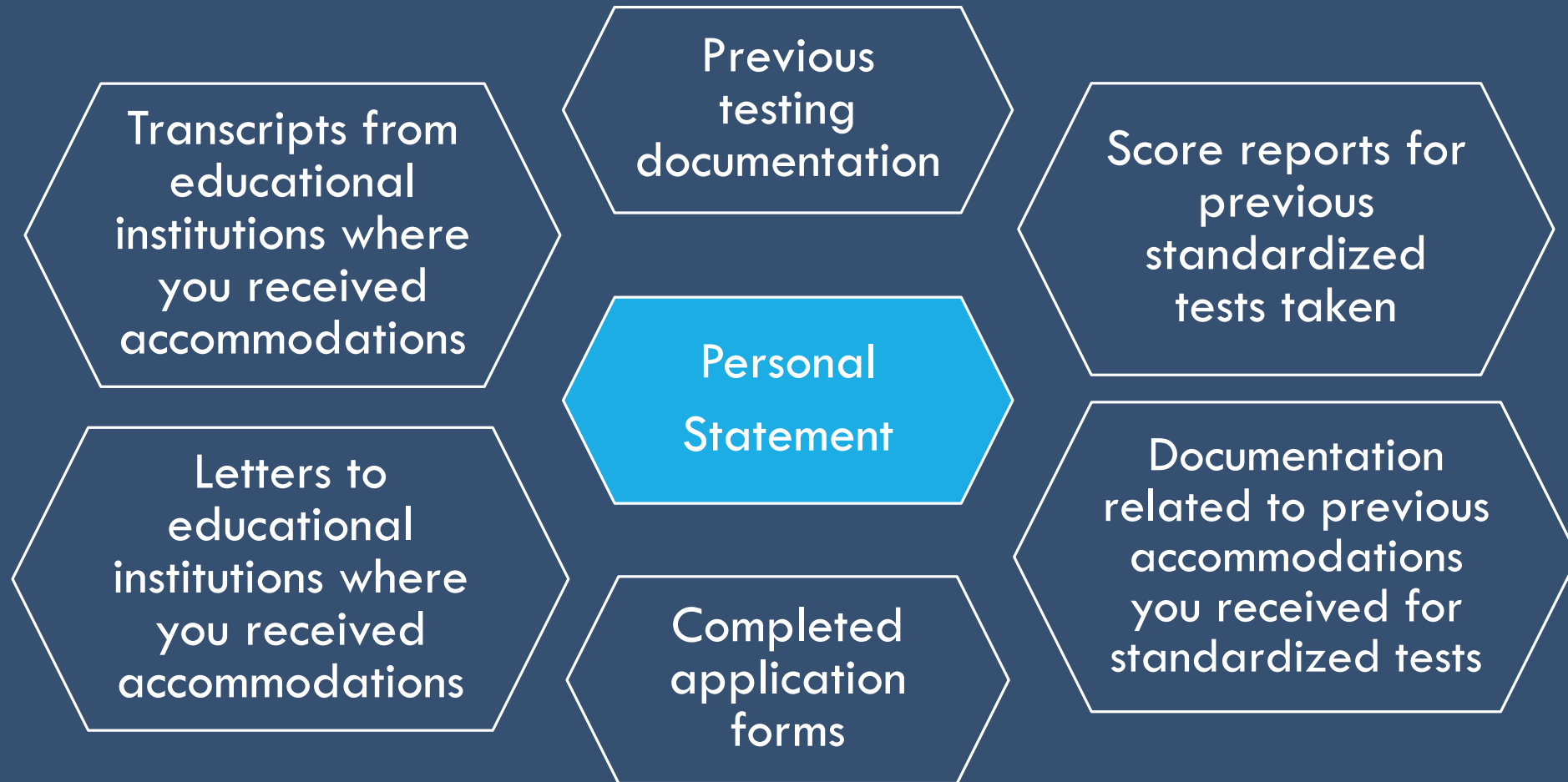

NY (UBE)

Filing Deadline: April 30
Encouraged to file as early as 6 months prior to exam administration (February)

NYLE

Filing Deadline:
90 days prior to exam date

MPRE

Must apply prior to registering for exam.
