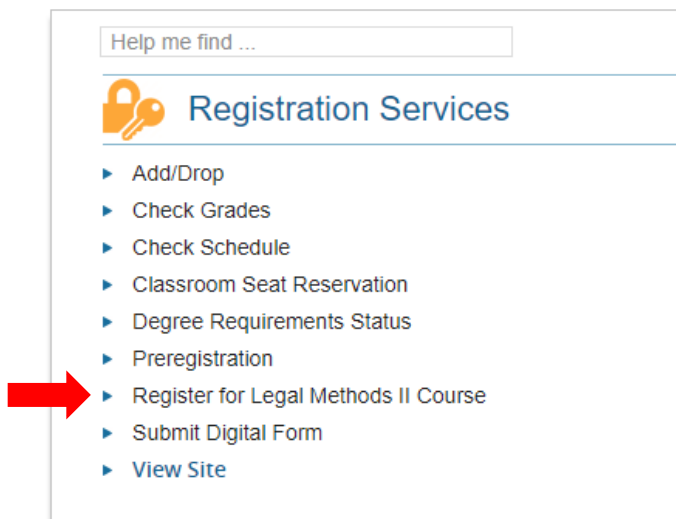


New: Legal Methods II Switches in LawNet

1L Students can now directly register for a different Legal Methods II course with open seats in LawNet. Follow the instructions and screenshots below.

Login to LawNet and select **Register for Legal Methods II Course** under the Registration Services menu.



PLEASE NOTE that you can register for only ONE Legal Methods II course. If you would like to register for another class (with open seats), you will have to drop from the existing Legal Methods II registration.



Before dropping your existing registration, make sure there are open seats in the class you want to add yourself into. Registration Services cannot add you back into a course if there are no open seats.

Action Column

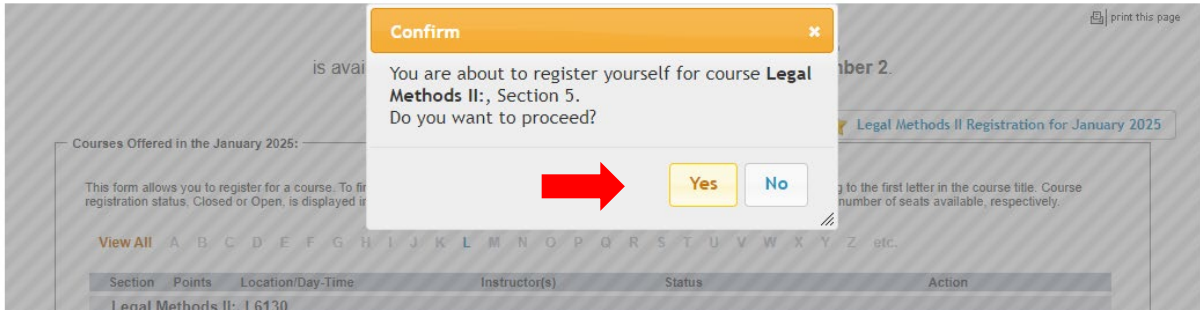
If a course is available for registration, the status for that course will say, **Open**, and a **green plus** button will be present in the **Action** column, on the right.

Also in the **Action** column, you can click on the **magnifying glass** button to view the course description, the **bar chart** button to view the course evaluations, or click on the **textbook** button to see a list of required texts.

Click on the **green plus** button in the **Action** column for that class. The system will then ask you to confirm your registration. Click **Yes** to confirm.

If you try adding a Legal Methods II section when you are already registered for one, you will see an error message.

Once you confirm your registration, you will see the course that you chose displayed on the next page under the heading, **Courses you are currently registered for**.
